Agenda Item #1: Welcome and Introductions

Meeting was called to order at 12:10 PM. Co-chairs described the goals of the meeting to discuss an agenda and workplan for the year ahead.

Agenda Item #2: Briefing on GGRA, 40 by 30, and 2016 Work Plan and Schedule

MDE Air Director Tad Aburn's presentation gave an overview of what a 40% GHG emission reduction by 2030 could entail, and provided a proposed 2016 MWG schedule.

Agenda Item #3: Discussion

- Working group members discussed several difficult issues surrounding the emission growth modeling
 that will be a part of the planning process for a 2030 goal, including how to account for multiple
 possible economic growth and technology adoption trends, and how to incorporate equity
 considerations.
- Members discussed options to monitor existing programs' performance while evaluating their potential impact in 2020-2030,
- Members discussed the timing of agenda items proposed in the presentation, in particular:
 - o An expert panel on methane leakage, which will take time to put together in a way that reflects the differing perspectives within the working group; and
 - The Regional Greenhouse Gas Initiative (RGGI), which is in the midst of its 2016 Program Review.
- Members discussed the process through which potential panelists for upcoming issue-specific meetings should be selected.
- Members discussed whether individual members should be tasked with specific items for exploration in between meetings, with subsequent reports back to the MWG, as appropriate.
