Interfere with the efficacy of the corrective measures or Honeywell's ability to (a) comply with the Performance Standards, the Groundwater Gradient Monitoring Plan, the Surface Water Monitoring Plan, the Environmental Media Monitoring Plan, and the Surface Soil Monitoring Plan, or any other monitoring plan in effect.

(b) Increase risks to health or the environment from the conditions at the site.
