Commission Chair, Ruth Ann Norton, called the meeting to order at 9:30 A.M. with welcome and introductions.

Opening Remarks, Acknowledgements, and Other Discussions:

Chair Norton welcomed everyone to the November 7 meeting of the Maryland Lead Poisoning Prevention Commission. Chair Norton highlighted the following items:

- Progress is being made on replacing the current Commissioner representatives of the House and Senate.
- New standards are forthcoming to de-lead the gasoline used in jet aircraft used for commercial transport. - The Food and Drug Administration (FDA) recently put out a health alert and recall on WanaBana Apple Cinnamon Fruit Puree Pouches. Approval of Minutes:

A motion was made by Anna Davis, seconded by Adam Skolnik to accept the October 5, 2023 minutes as distributed. All present Commissioners were in favor; the minutes were approved.

Old & New Business:

- BCHD CLPPP Fiscal Year Report: Commissioner, Camile Burke presented on the Childhood Lead Poisoning Prevention Program. Commissioner Burke highlighted the following: Social Determinants of Health; Elements of a Healthy Community; Lead Poisoning Data by Fiscal Year; Average Time to Complete Initial Home Visit (Days); 2020-2022 Possible Sources of Lead Poisoning for Pre 1950 Rentals; COVID-19 Impact on Blood Lead Testing; Post COVID impact; Case Management Challenges; Outreach; Partners; Point of Care Testing; 2023 National Childhood Lead Poisoning Prevention Week; 2023 Healthy HOmes Workshop Survey Highlights; and Moving Forward. The presentation was provided to the Commission titled "2023 Lead Commission Prez" prior to the meeting.
- **MDE Childhood Lead Registry Report 2021**:
 - Fred Banks presented on the Childhood Blood Lead Surveillance in Maryland Annual Report 2021. Highlights include the following: CY 21 Surveillance; Statistical Report; Reduction in Blood Lead Testing 2020 vs. 2021; Data Quality; Medical and Environmental Case Management in Maryland and Baltimore City; Sources of Lead; Lead Hazards Identified by Housing Type; Challenges and Opportunities; and Goals for Future Data Reporting.
 - o Also, During the presentation Chris Corzine, from MDE's Attorney General's Office, indicated that the department does file the regulations with regard to scheduling environment investigations which includes the closure of a case. There are protocols set forth in regulation that the department follows. In those cases that are closed, the department is following the procedure it is required to do so before the case is closed. The Environmental Investigation Regulations are set forth in COMAR 26.16.08, with the scheduling governed by 26.16.08.05. The presentation will be provided on the MDE website in the near future which will be available to the public.

Agency Hot Topics/Current Events

- MDH (Maryland Department of Health) Commissioner, Dr. Cliff Mitchell updated the Commission with the following:
 - MDH is continuing to work on its equity assessment of the lead program across its various product lines and service lines including its home visiting program, and its collaboration with medicaid and DHCD. In this effort, MDH will collaborate with MDE.
 - o MDH will be working with MDE on Outreach in addition to the Baltimore City Health Department.
 - MDH's preventive medicine resident is actively working on enhancing direct engagement with healthcare providers by detailing information on lead, asthma, and healthy homes to increase provider awareness.
 - MDH is allocating additional funding for a second year, utilizing the remaining balance from the \$500,000 received last year from the Association of State and Territorial Health Officials (ASTHO). This funding will be directed to 13 local health departments currently not involved in MDH's Medicaid home visiting program, specifically to support case management activities. Each of these local health departments will receive approximately \$15,000 to bolster their case management efforts.
 - O MDH is excited about collaborating with MDE for the implementation of HHLPSS (Healthy Homes Lead Poisoning Surveillance System). The plan is to partner with MDE to encourage MDH's local health departments to enhance the connection between case management and prevention activities. Additionally, the collaboration aims to improve MDH's statewide visibility regarding case management activities.
- MDAAP (American Academy of Pediatrics, Maryland Chapter) Commissioner, Dr. Paul Rogers updated the Commission, mentioning his recent email exchanges with the head of California's lead poisoning prevention program. The discussions primarily focused on lead testing of water in schools. Further details about California's labeling process are expected to be provided soon.
- MSDE/OCC (Maryland State Department of Education/Office of Child Care) Commissioner Manjula Paul informed the Commission that she was thrilled to receive a message yesterday from Johns Hopkins, MSDE's collaborator in conducting parent surveys. Recently, Johns Hopkins conducted a survey involving parents of children in childcare programs. Although they anticipated 300 participants, the actual turnout was approximately 600 parents. One of the survey questions focused on late testing and the obstacles parents face in getting their children tested. Johns Hopkins has informed MSDE that the results are now available. Commissioner Paul will share the findings with the Commission once it is published.
- **BC-DHCD** (Baltimore City Department of Housing and Community Development) Katherine Taylor updated the Commission on BC-DHCD's efforts to prioritize vulnerable populations, specifically immigrants and refugees. The department is collaborating with the mayor's office to translate all materials and applications, ensuring better outreach to these groups. Additionally, BC-DHCD is working with various stakeholders known for their immigrant-friendly initiatives to establish trust within these populations, and the progress in this regard has been positive.
- **BCHD** (Baltimore City Health Department): Cambille Burke informed the Commission that BCHD is entering into a renewed partnership with the Maryland Homeschool Association (MHA), and they are currently exploring the details of this collaboration. MHA has initiated discussions with BCHD, expressing interest in engaging in conversations about lead. BCHD will keep the Commission informed about the outcomes of these discussions.
- **GHHI** (Green & Healthy Homes Initiative)
 - Wes Stewart reported that GHHI has a dedicated team for outreach and case management to assist individuals in accessing the state's and city's lead grant programs. This support extends to homeowners, rental property owners, and tenants. GHHI can guide them through the process of accessing lead grant programs and connect them with necessary resources. In Baltimore City, GHHI is open to receiving referrals. With \$2.5 million in ARP funding specifically allocated for lead houses in Baltimore City, GHHI is addressing not only lead hazards but also other healthy homes concerns, weatherization, and electrical issues. The focus is not just on making homes lead-safe but also on enhancing the family's long-term financial stability by addressing various hazards, structural defects, and supporting weatherization efforts. GHHI has \$2.5 million in funding earmarked for direct use in addressing lead-related issues.

11/07/23 TTY Users: 800-735-2258 Chair Norton mentioned that GHHI is collaborating with Hopkins on an injury prevention study. GHHI is actively seeking 300 families in Baltimore City and Baltimore County with children aged 7 and under to provide injury prevention measures. These measures may include replacing mini-blind cords, installing window guards, or adding grab bars, among other actions. It's important to recognize that injuries affect not only older adults but also children. In the context of any of GHHI's grants, whether focusing on asthma, injury prevention, or weatherization, GHHI constantly checks for lead in houses and addresses it as part of the remediation process. For an upcoming site visit with Fannie Mae, GHHI has identified a family through MDH dealing with asthma. GHHI initially worked on asthma-related issues and expanded their efforts to include broader prevention measures for the family.

Commissioner Comments and Updates:

Commissioner, Barbara Moore from Mt. Washington Pediatric Hospital (MWPH) updated the Commission that MWPH has had an increase in the number of children that have been referred to the clinic. Currently MWPH is up to 46 or 47 new referrals just since January. Baltimore City and the state have been quick and responsive when MWPH asks for reports to be sent to them. MWPH recently had a very complicated case with elevated lead levels and currently has another very complicated case with a child with very high lead levels.

A motion was made by Barbara Moore seconded by Cliff Mitchell to adjourn the meeting. All present Commissioners were in favor and the meeting was adjourned at 11:23 a.m.

Maryland Lead Poisoning Prevention Commission Membership Continued

Composition

The Commission categories are established by statute. Md. Code Ann., Envir. § 6-807. All positions, with the exception of the member of the House and the member of the Senate are appointed by the Governor. The terms of the Governor's appointees are four years but a member at the end of his/her term continues to serve until a successor is appointed. The Governor appoints the Chair from among the members. There is no statutory term for the chairmanship.

Recent Changes to Lead Commission Membership

In May of 2020, Senate Bill 18 (SB18) was passed in Maryland. SB 18 alters the membership of the Lead Poisoning Prevention Commission to include one representative each from a nonprofit focused on lead poisoning prevention issues and the American Academy of Pediatrics, Maryland Chapter; removed the Commission members representing a premises liability coverage insurer and a financial institution that makes loans secured by rental Property; repealed certain requirements for a window replacement program; altering the subjects that the Commission may appoint a subcommittee to study to include case management, lead paint abatement service provider education and training, and blood lead testing; etc. These changes become effective October, 1, 2020.





GLO Center Direct TA Process



GLO Community Identification & Selection

- Pathways for community identification:
 - EPA identifies communities through data and knowledge of lead problems, other TA providers, and coordination with states
 - Communities self-identify through the WaterTA request form
- EPA is responsible for community selection.
- Top priorities for community selection:
 - Community need
 - Presence of lead service lines
 - Openness to receive TA



Lead and Copper Rule Improvements (LCRI) National Primary Drinking Water Regulation Proposal

- Advancement in protecting children and adults from the significant, and irreversible, health effects from being exposed to lead in drinking water.
- Based on the science and existing practices utilized by drinking water systems.
- Builds on previous version of the Lead and Copper Rule.

Lead and Copper Rule Improvements: Key Provisions

- Achieving 100% Lead Pipe Replacement within 10 years
- Locating Legacy Lead Pipes
 - Water systems are currently required to provide an initial inventory of their lead service lines by October 16, 2024. Under the proposed LCRI, all water systems would be required to regularly update their inventories, create a publicly available service line replacement plan, and identify the materials of all service lines of unknown material.
- Improving Tap Sampling
 - Water systems would be required to collect first liter and fifth liter samples at sites with lead service lines and use the higher of the two values when determining compliance with the rule.
- Lowering the Lead Action Level from 15 ppb to 10 ppb
- Strengthening Protections to Reduce Exposure
 - Water systems with multiple lead action level exceedances would be required to conduct additional outreach to consumers and make filters available to all consumers (multiple ALEs).



LCRI Next Steps

- EPA invites members of the public to review the proposed LCRI and supporting information and provide written comments at www.regulations.gov, Docket ID Number: EPA-HQ-OW-2022-0801. Comments must be submitted to the public docket during the 60-day public comment period.
- EPA held an informational webinar for the public on December 6, 2023 about the proposed LCRI.
- EPA will also hold a virtual public hearing on January 16, 2024.
- Goal is to finalize LCRI by October 2024.

Lead Hazard Reduction Grants

PURPOSE

- Reduce lead-based paint hazards in Baltimore's occupied housing stock
- Identify lead in owner occupied and rental occupied units
- Reduce exposure to lead-based paint hazards to children under 6 years old.
- Educate communities on lead hazards, sources of lead-based paint poisoning, and ways to reduce and eliminate such hazards





Lead Hazard Reduction Program

A grant-funded program that works with applicants to apply interventions to make the home safe for the family and children that live there. LHRP helps to determine the presence and location of existing lead hazards and select cost-effective and sustainable interventions to reduce or eliminate lead hazards.



SERVICES INCLUDE BUT ARE NOT LIMITED TO:

- Free lead-based paint inspection and risk assessment
- If identified as lead and/or healthy home hazards
 - New windows
 - Doors
 - Siding/Trim
 - Exterior & interior painting
 - Porch repair
 - Home safety measures
- Temporary relocation during lead risk reduction

Challenges and Solutions

- Recovering from COVID-19 Pandemic
 - Halt in unit production from start of grant to March 2022 due to stay-at-home order
 - Clients hesitant to have staff and contractors in home
 - Staff Turnover
- Procurement Delays
 - Delayed Contractors RFQ
- Intake and Enrollment
 - Clients received during the pandemic were put on hold due to delay of unit production
- Increased production costs and hazards

- Extension Granted by HUD on both grants to meet goals
- Unit Production started on March 2022 with the help of an Emergency Contract from Alice Kennedy
- Expediated hiring process to increase staff in program
- Utilizing all forms of E-communications to complete intake process including an online portal for clients to submit documents
- Increased outreach efforts by attending over 30 community events, hosting 12 presentations for local community organizations, and utilizing MIMA
- Utilize ARPA funds address all lead-based paint hazards and healthy homes hazards.
