

Old Business

- Lead Commission Recognition and Awards: Yearly, the Lead Poisoning Prevention Commission aims to recognize excellence, innovation, and leadership from within the Lead Poisoning Prevention community. The Commission members voted amongst the nominees previously submitted and the following nominees received an award:
 - George Wesley Stewart was awarded with the Outstanding Child Health Environmental Advocate Award
 2022
 - Barbara Moore was awarded Outstanding Advocate Award 2022
 - Wendy Phillips was awarded Special Recognition Award 2022
- **Results of Objective Survey:** In September 2022, Wendy Phillips sent a survey to the Commissioners asking them for their top 3 objectives that they would like to see the Commission achieve on behalf of the state over the next several months. The results document titled, "Top 3 Objectives (Responses).pdf" was sent to the Commission and discussed at the meeting.
- Lead Week: Ruth Ann Norton informed the Commission that Lead Week will begin on Sunday, October 23, 2022. There will be a joint agency social media campaign with the U.S. Department of Housing and Urban Development, U.S. Environmental Protection Agency, Centers for Disease Control and Prevention, Maryland Department of the Environment (MDE), Maryland Department of Health (MDH), Green and Healthy Homes Initiative (GHHI), Baltimore City and others.
 - o **GHHI:** Ruth Ann Norton reported that on Monday, October 24, 2022, GHHI will launch the 1k home project in Baltimore. GHHI will be providing full funding for 1 thousand families in Baltimore to do energy efficiency, full lead hazard control, weatherization, asthma reduction, and trip and fall injury all in one holistic approach to housing. On October 25, 2022 there is a tour for Derek the Dinosaur who will be doing a book read around the area. GHHI will also be hosting other events throughout the week.
 - MDH: Cliff Mitchell reported that MDH will be stressing the importance of the key messages for the 2022 Lead Poisoning Prevention Week as 1) The transition from 5 micrograms to 3.5 micrograms on October 28, 2022 for notification of parents and property owners if there is a child who is found to have a lead level of 3.5 micrograms per deciliter or above and 2) Continued importance of children getting testing.
 - o **BCHD (Baltimore City Health Department):** Camille Burke reported that BCHD will be partnering with the Enoch Pratt Library and will be there each day of Lead Week to engage in conversations with the public. On October 17, 2022 BCHD will relaunch its media campaign which will run through December 2022.
 - Baltimore County: An employee from Baltimore County informed the Commission that it is doing
 in-person events and also for the entire month of October it will be running ads on Maryland Public
 Television and WBAL-TV 11 Baltimore.

- Public Educational Video/Reels from MDE (Paula Montgomery): Paula Montgomery with the assistance of MDE's Office of Communications, developed an educational video which was shown to the Commission. - MIA Reporting (Benita Cooper): Benita Cooper addressed the concerns that were raised in the New York
 Times article "Copy of How 2 Industries Stymied Justice for Young Lead Paint Victims". The article was initially
 discussed and provided to the Commission for the April 7, 2022 meeting. Benita Cooper gave some background
 on the article and informed the Commission that the issues raised in the article have not been an issue in the state
 of Maryland.
- Preliminary Data Report on Childhood Lead Registry (CY2021 Childhood Lead Surveillance in MD Report) (MDE) (LPPP): The Commission was provided a copy of a powerpoint presentation titled, "Lead Surveillance Mid-Year 2021 Report.pdf" which Rena Boss-Victoria discussed at the Commission meeting.

<u>Pending Legislative Action Dates:</u> No new updates.

AgencyHot Topics/Current Events:

- MDE (Maryland Department of the Environment): Paula Montgomery indicated that MDE applied for a HUD grant, which is currently pending, for a study to evaluate lead hazards at lower blood lead levels.
- MDH (Maryland Department of Health): Cliff Mitchell provided the Commission a revised Blood Lead Testing Certificate MDH Form 4620 titled,
 - "MDHBloodLeadTestingCertificate_4620_Revised2022_Draft_v3_watermark.pdf" and explained what revisions were made to the form. If there are no further revisions the form will be submitted to become the new official form.
- Maryland DHCD (Maryland Department of Housing and Community) Development: No updates provided.
- **BCHD** (Baltimore City Health Department): Camille Burke reported that BCHD had an influx of 8 applicants for sanitarian and 7 of the 8 will be hired. BCHD is forging a partnership with Morgan State's Environmental Science & Food and Nutrition with the intent on increasing sanitarians for BCHD.
- MDAAP (American Academy of Pediatrics, Maryland Chapter): Paul Rogers provided the Commission the document titled, "Project ECHO for MD LPPC.pdf" and indicated that the ECHO program is now in place and MDAAP's goal is to work with 17 pediatric practices to see how testing, follow-up, education, and counseling of families can all be improved. The program will continue for 9 months and go through April. Paul Rogers indicated that he will be sharing information that MDAAP achieves from this special study.

- (b) For individuals born before January 1, 2015 in the 2004 Targeting Plan for Areas at Risk for Childhood Lead Poisoning].
- (3) (text unchanged)
- (3-1) "Blood lead reference value" means a blood lead level of 3.5 micrograms per deciliter.
- (4)—(5) (text unchanged)
- (6) ["Child at high-risk" means a child who resides, or has previously resided, in an area within the State that has been designated as high-risk for lead poisoning by the Department in the 2015 Targeting Plan.] *Repealed*.
- (7) "Department" means the Maryland Department of Health.
- (8) ["Elevated blood lead level" means:
- (a) A blood lead level of 10 micrograms per deciliter or greater; or
- (b) A blood lead level of 5 micrograms per deciliter or greater for a blood test performed after March 28, 2016.] *Repealed*.

.04 Blood Tests for Lead Poisoning.

A. [Effective March 28, 2016, a] *A* primary care provider for a child who resides, or who is known to have previously resided, in an at-risk area shall administer a blood test for lead poisoning during the 12-month visit and again during the 24-month visit.

B. [Effective March 28, 2016, a] *A* primary care provider for a child who is 24 months old or older and younger than 6 years old who resides, or who is known to have previously resided, in an at-risk area as defined in the [2004] *2015* Targeting Plan for Areas at Risk for Childhood Lead Poisoning, shall administer a blood test for lead poisoning if the:

- (1)—(3) (text unchanged)
- C.—D. (text unchanged)
- E. A primary care provider shall administer a blood test for lead poisoning, by venous methodology, if the results of a capillary blood test for lead poisoning indicate [an elevated blood lead level] a blood lead level that exceeds the blood lead reference level.
- F.—G. (text unchanged)
- H. Bona Fide Religious Beliefs At Risk.

- (1) If the parent or guardian of a child [who resides or has previously resided in an at-risk area that is not a high risk area] refuses to consent to a blood test for lead poisoning due to the parent or guardian's stated bona fide religious beliefs and practices, a primary care provider shall:
- (a) Counsel the parent or guardian that the blood test for lead poisoning is required by law due to the fact that their child is at risk for having [an elevated blood lead level] a blood lead level that exceeds the blood lead reference level;
- (b) (text unchanged)
- (2)—(3) (text unchanged)
- I. [Bona Fide Religious Beliefs High Risk.
- (1) If the parent or guardian of a child at high risk refuses to consent to a blood test for lead poisoning due to the parent or guardian's stated bona fide religious beliefs and practices, a primary care provider shall:
- (a) Follow the procedures set forth in §H(1) and (2) of this regulation; and
- (b) If a provider determines that a child is at a substantial risk of harm from lead exposure, the provider shall follow applicable law if the child's parent or guardian continues to refuse to have the child tested.
- (2) If all the responses to the lead exposure risk questionnaire are negative, the provider shall complete the form issued by the Department indicating that the questionnaire was completed.] *Repealed*.

Child Care Program Definitions

Family Child Care Provider: A Provider offer care in their own home to one or more children who aren't related to the provider. To ensure a safe environment, Maryland limits the number of children in a family child care home. A provider may care for up to eight children with no more than two under the age of two. Regulated under the Code of Maryland Regulations <u>COMAR 13A.15</u> which require that you obtain a "certificate of registration"

Large Family Child Care Home: A provider may care for between nine and 12 children with no more than four under the age of two. Regulated under COMAR 13A 18

Child Care Center: Under Maryland law, a child care center is run by an individual, an agency, or an organization. Regulated under COMAR 13A 16 (Licensed Child Care Centers .Serves Children of all ages from infancy to school age

Letters of Compliance: Nursery Schools and Child Care Programs run by tax-exempt religious organizations. Regulated under COMAR 13A.17. Serves children ages 2 yeas and above and can not provide care to children younger than two years of age .

Informal Child Care: Child care is when a friend, relative, or nanny cares for a child in the family home or in his or her own home. Though exempt from regulation under Maryland Law, The Office of Child Care scholarship program follow monitoring procedures to ensure health and safety of the children.

Child Care COMAR

Environment Requirement:

COMAR 13A.16 to18.05 Physical Plant and Equipment .05 Lead-Safe Environment.

B. If the child care center is a **residential rental property constructed before 1978**, which is an affected property as defined by Environment Article, §6-801(b), Annotated Code of Maryland, the operator shall submit a copy of the current lead risk reduction or lead free certificate.

Children Testing:

COMAR13A.16.03 Management and Administration .04 Child Records.

- **E.** The operator shall maintain documentation that, as required by COMAR 10.11.04, each child admitted to, or continuing in, care has received:
 - (1) An appropriate lead screening, if the child is younger than 6 years old and was born before January 1, 2015; or
 - (2) A lead test when the child is 12 months old and again when the child is 24 months old, regardless of where the child resides, if the child was born on or after January 1, 2015.

Needs for Consideration

- 1. MDE COMAR: Request for MDE COMAR to add: Regardless of Owner/Rental status, Lead inspection requirement to businesses operated in Pre 1978 buildings that services to young children from birth to 6 years.
- 2. Water Testing: Request for MDE Regulation and funding for free water testing and mitigation support for child care facilities operating in Pre 1978 built buildings.
- 3. Request that MDH Immunization & MDH/MDE Lead testing forms to be merged. Child care program is the only Federal and State funded program that reviews and enforces age appropriate immunization (MDH 896)and Lead Testing(MDH 4620) for more than 200,0000 plus children. In Order to support MDH/MDE efforts and alleviate the work burden ,it is requested to have both information on one

MDH form.
