Quantum Maryland, LLC has coordinated with our environmental consultant, Geo-Technology Associates, Inc., on the attached response to your May 31, 2023 letter requesting additional information to evaluate compliance with the Land Use Controls set forth in the Environmental Covenant issued for the Former Alcoa Eastalco Works Property located at 5601 Manor Woods Road in Frederick, Maryland (the "Site"). The enclosed CD contains supporting documentation as requested in your letter, including but not limited to, dewatering documentation received from our contractors, final permits for stormwater discharges associated with construction activity issued for the Phase I utility installations, surface water and sediment sampling results, Health and Safety Plans, maps and photographs of all on-site groundwater monitoring wells, Annual On-Site Cap Inspection Forms, and Semi-Annual Summary Reports/Inspection Reports.
