**Re: Proposed Modifications to Bottled Water Delivery & Private Supply Well Sampling Programs**

Inactive Exxon Facility #28077  
14258 Jarrettsville Pike, Jacksonville, Maryland

Dear Mr. Meade:

As you are aware, for the past four years, Exxon Mobil Corporation (ExxonMobil) has been conducting investigation and remediation activity in response to the discovery of a release of gasoline from an underground storage tank system at the former Exxon service station on Jarrettsville Pike. While done with the best of intentions and as a temporary, precautionary measure and until adequate sampling had been conducted, ExxonMobil initiated bottled water deliveries to a number of residences and businesses within the vicinity of the service station site without the direction and approval of the Maryland Department of the Environment (MDE). Currently, 126 properties receive bottled water from ExxonMobil. In addition, since February 2006, ExxonMobil has conducted routine water sampling of up to 271 (currently 248) private supply wells (PSWs) on a regular sampling schedule as directed by the MDE. After nearly 4 years of investigation, remediation and monitoring of area ground water conditions, the available data support modifications to the current remedial program. Based on the overall investigation and remediation, and supported by the site-specific PSW data included with this submission, ExxonMobil proposes the following changes:

- 1) Discontinuation of the delivery of bottled water;
- 2) Modification of the monthly PSW sampling schedule to a quarterly schedule;
- 3) Modification of the quarterly PSW sampling schedule to a semi-annual sampling schedule; and
- 4) Discontinuation of PSW sampling for those properties that are currently on a semi-annual sampling schedule.

In making this proposal, ExxonMobil offers the additional information below.

- ExxonMobil has installed Point of Entry Treatment (POET) systems at 14 locations at the direction of the MDE. Based on sampling data collected by ExxonMobil, all PSWs within the study area that have ever exceeded MDE standards for gasoline constituents have a POET system. Of the 14 properties where ExxonMobil installed POET systems, only 1 property (14307 Jarrettsville Pike, commercial property) currently has gasoline constituents in the influent above MDE standards (based on November 2009 data collected by ExxonMobil). In addition, ExxonMobil conducts regular POET system performance sampling (i.e. influent, midpoint, and effluent sampling) for the 14 ExxonMobil-installed POET systems.
- Since February 2006, the properties currently receiving bottled water have shown no gasoline constituents in their PSWs above MDE standards with the exception of 5 properties that have POET systems (3 ExxonMobil installed and 2 installed by others). Furthermore, based on November 2009 data the properties currently receiving bottled water, excluding 2 POET locations (1 ExxonMobil installed and 1 installed by others), currently do not exceed 20 parts per billion (ppb) of methyl tertiary butyl ether (MTBE), the MDE's standard for that compound. In fact, the properties currently receiving bottled water do not exceed 5 ppb MTBE (except 3 POET locations).
- A comprehensive and effective investigation and remediation effort has been implemented to address the release discovered in February 2006. A ground water remediation system comprised of up to 91 recovery wells has been operated since 2006. This ground water remediation system, aided by the naturally convergent groundwater flow toward the "strike line," has produced significant improvement in ground water conditions. This overall improvement trend has continued through the September 2009 full ground water sampling event. The ground water remediation activity will continue in accordance with the MDE's direction and approval. The ground water remediation will also be subject to on-going review and potential modifications (with advance MDE approval) to optimize remediation as we work to meet the 5-year remedial goal set forth in the Consent Decree.

A site plan depicting the locations of the homes and/or businesses and a summary table with property address information for the properties that currently receive bottled water are included as **Figure 1** and **Table 1**, respectively. Site plans depicting the current PSW sampling schedule and the proposed sampling schedule are attached as **Figures 2 and 3**, respectively. Detailed information regarding the history of bottled water delivery and PSW sampling programs is presented in the sections below. The sections below also provide summaries of the pertinent data to allow for the assessment of the analytical results in the context of the MDE's procedures and standards.

#### **Applicable MDE Procedures and Standards**

This section summarizes the applicable MDE procedures and standards and presents an evaluation of the current remedial programs and the associated data in light of these procedures and standards. A summary of the applicable MDE procedures and standards considered by ExxonMobil in preparing this proposal is presented below. The standards and procedures presented below have been compiled from MDE correspondence specific to this project, general MDE correspondence and applicable MDE regulations.

- As with any remediation, the MDE expects the procedures employed to be protective of human health and the environment.

- During the early phases of an emergency response investigation, the MDE may direct that certain measures be undertaken as a precautionary measure (e.g. one-half mile radius PSW sampling). Once conditions are more clearly understood using site-specific data, initial precautionary measures may be modified by the MDE to reflect actual known conditions.
- The MDE has established standards and action levels (collectively “standards”) for PSWs that it applies on a State-wide basis. These standards establish the levels which the MDE has determined to be safe for drinking water.
- The MDE has established a 20 ppb standard for MTBE, based on an aesthetic condition (i.e. taste and odor) but has also determined that this 20 ppb standard provides a large margin of safety from toxic effects. Thus, according to the MDE, the 20 ppb standard for MTBE is conservatively protective of potential human health concerns.
- Also consistent with its established State-wide standard of 20 ppb for MTBE, the MDE has a public policy whereby a POET is installed (or some alternative measures are taken) if MTBE is detected in a PSW at levels above 20 ppb.
- Specifically with respect to the Jacksonville, MD matter, the MDE has communicated the following position to ExxonMobil: although ExxonMobil voluntarily elected to institute a bottled water program, MDE approval is required prior to discontinuation of this voluntary program.

ExxonMobil believes that the summary above accurately reflects the applicable MDE procedures and policies that are pertinent to the assessment of the analytical results. A discussion of the bottled water and PSW sampling programs is presented below.

#### **Bottled Water History**

Although the MDE did not direct ExxonMobil to provide bottled water, MDE has requested the opportunity to review and approve the discontinuation of the bottled water program. A summary of the history of bottled water delivery and an analysis of the PSW data for the properties currently receiving bottled water is presented below.

- Bottled water delivery was initiated in February 2006 as a temporary precaution while ExxonMobil, working under the direction of the MDE, proceeded with a groundwater investigation and remediation.
- The delivery of bottled water was a voluntary measure initiated by ExxonMobil. Consistent with its procedures discussed above, the MDE did not direct ExxonMobil to provide bottled water. Rather, the MDE directed ExxonMobil to install POETs at those locations where MDE standards were exceeded (as well as other locations where the MDE believed a POET should be installed for precautionary reasons).
- Initially, the delivery of bottled water followed the PSW sampling program (which was directed by the MDE). Consistent with a MDE modification to the PSW sampling schedule on or about April 2006, in May 2006 there was an initial reduction in the area and number of properties receiving bottled water.
- In September 2006, ExxonMobil intended to implement another reduction in the area and number of properties receiving bottled water. However, ExxonMobil did not request and receive prior approval from the MDE for such reduction. The proposal was retracted by ExxonMobil. The delivery of bottled water, with minor adjustments, has remained essentially unchanged for the last 3 years.

- This proposal to discontinue the provision of bottled water is submitted to the MDE for its review and consideration in accordance with its recommendations communicated in September 2006.

### **Bottled Water Technical Data**

To facilitate the MDE's review of PSW sampling results for the properties currently receiving bottled water, a number of figures and tables are described below and attached. These data have been previously provided to the MDE in regular submissions over time. These tables and figures, unless noted otherwise, include data collected through November 2009 (see sampling dates on tables). Please advise us if there are any other summary tables or figures required by the MDE to complete its assessment of the analytical results for these properties.

- **Figure 1:** Locations of properties currently receiving bottled water from ExxonMobil - This figure includes a) color-coded shading of the property to illustrate the maximum MTBE concentration for each property, b) a color-coded dot for each property to show the most recent MTBE result and c) symbols to show where POETs were installed by ExxonMobil.
- **Table 1:** Summary of properties currently receiving bottled water from ExxonMobil - This table provides the owner name and address of the properties that are currently receiving bottled water. Table 1 also identifies which properties are commercial and which properties have a POET installed by ExxonMobil (and installed by others, where known).
- **Table 2:** Maximum MTBE concentrations for properties currently receiving bottled water from ExxonMobil - This table provides the sample date and maximum MTBE concentration in descending order.
- **Table 3:** Maximum benzene concentrations for properties currently receiving bottled water from ExxonMobil - This table provides the sample date and maximum benzene concentration in descending order.
- **Table 4:** Summary of most recent PSW data for properties currently receiving bottled water from ExxonMobil – This table provides the most recent results for MTBE, benzene, toluene, ethylbenzene, xylene (BTEX) and other Oxy-5 compounds.

In addition to the information above, a complete summary of all historical MTBE, BTEX and other Oxy-5 compounds for all PSW sampling conducted by ExxonMobil, including those properties currently receiving bottled water from ExxonMobil, is provided on a CD as **Attachment A**.

### **PSW History**

At the direction of the MDE, ExxonMobil has conducted a sampling program to monitor water quality in PSWs in the vicinity of the Site. Figure 2, identifies the properties within an approximate ½ mile radius where PSW sampling has been conducted by ExxonMobil. The shading on this map shows the current sampling schedule as directed by the MDE. A summary of the history of the PSW sampling program and an analysis of the PSW data for the properties sampled by ExxonMobil is presented below.

- PSW sampling was initiated in February 2006 in the immediate vicinity of the station.
- Based on the findings of the investigation and at the direction of the MDE, PSW sampling was expanded to include additional properties within an approximate ½ mile radius of the Site.
- In December 2006, upon review of the data collected to that point, the MDE directed ExxonMobil as to its sampling locations and frequency.

- Currently, 248 PSWs are sampled on a regular sampling schedule. The PSW sampling program conducted by ExxonMobil has four components:
  - Biweekly sampling of 2 PSWs;
  - Monthly sampling of 42 PSWs;
  - Quarterly sampling of 67 PSWs; and
  - Semi-annual sampling of 137 PSWs.
- The locations of the PSWs identified by sampling frequency and area are shown on Figure 2.
- The current PSW sampling program, with minor adjustments, has remained essentially unchanged for the last 3 years.

### **PSW Technical Data**

To facilitate the MDE's review of PSW sampling results, a number of figures and tables are described below and attached. These data have been previously provided to the MDE in regular submissions over time. These tables and figures, unless noted otherwise, include data collected through November 2009 (see sampling dates on tables). Please advise us if there are any other summary tables or figures required by the MDE to complete its assessment of the analytical results for these properties.

- **Figure 2:** Current PSWs sampled by ExxonMobil - This figure includes a) color-coded shading of the property to illustrate the sampling frequency for each property, b) a color-coded dot for each property to show the most recent MTBE result and c) symbols to show where POETs were installed by ExxonMobil.
- **Figure 3:** Proposed PSWs sampled by ExxonMobil - This figure includes a) color-coded shading of the property to illustrate the proposed sampling frequency for each property, b) a color-coded dot for each property to show the most recent MTBE result and c) symbols to show where POETs were installed by ExxonMobil. This figure also includes designations to identify adjustments to the sampling frequency at select properties where the proposed frequency is more frequent than the geographic location would otherwise dictate. The letters shown on Figure 3 include "M" for a monthly sampling frequency, "Q" for quarterly, and "SA" for a semi-annual sampling frequency.
- **Table 5:** Summary of PSW locations currently sampled by ExxonMobil - This table provides the owner name and address of the properties that are currently sampled. This table also identifies the sampling frequency, commercial properties, and properties that have a POET installed by ExxonMobil (and installed by others, where known).
- **Tables 6A through 6C:** Maximum MTBE concentrations for PSW locations currently sampled by ExxonMobil - These tables provide the sample date and maximum MTBE concentration in descending order. There are three tables included with this proposal to identify the maximum MTBE concentrations. Table 6A identifies the monthly PSW sampling locations, Table 6B identifies quarterly PSW sampling locations and Table 6C identifies semi-annual PSW sampling locations. These tables also identify commercial properties and properties that have a POET installed by ExxonMobil (and installed by others, where known).
- **Tables 7A through 7C:** Maximum benzene concentrations for PSW locations currently sampled by ExxonMobil - This table provides the sample date and maximum benzene concentration in descending order. Similar to the tables above, there are three tables included with this proposal (Tables 7A, 7B and 7C) to identify the maximum benzene concentrations for the monthly, quarterly and semi-annual PSW sampling locations, respectively. These tables also identify commercial properties and properties that have a POET installed by ExxonMobil (and installed by others, where known).

- **Tables 8A through 8C:** Summary of most recent PSW data for PSW locations currently sampled by ExxonMobil – This table provides the most recent results for MTBE, BTEX and other Oxy-5 compounds. Similar to the tables above, there are three tables included with this proposal (Tables 8A, 8B and 8C) to identify the most recent PSW data for the monthly, quarterly and semi-annual PSW sampling locations, respectively. These tables also identify commercial properties and properties that have a POET installed by ExxonMobil (and installed by others, where known).

In addition to the information above, a complete summary of all historical MTBE, BTEX and other Oxy-5 compounds for the properties sampled by ExxonMobil is provided on a CD as **Attachment A**.

### **Conclusions**

Analysis of the extensive soil and groundwater analytical and hydrogeological information produced by the overall site investigation, as well as the data derived from the monitoring well network, has enabled us to better understand the overall nature, extent and distribution of the gasoline contamination. The ground water remediation system, aided by the naturally convergent groundwater flow toward the “strike line”, has produced significant improvement in ground water conditions. This ground water remediation will continue in accordance with the MDE’s direction and approval. The ground water remediation will be subject to on-going review and potential modifications (with advance MDE approval) to optimize remediation as we work to meet the 5-year remedial goal set forth in the Consent Decree.


As discussed above, the data from sampling the PSWs at the properties currently receiving bottled water indicate that either a) no gasoline constituents are present above the MDE’s state action levels or b) a POET is installed. As a result of ExxonMobil’s investigation and remediation, we do not believe that gasoline constituents above the MDE’s state action levels will be detected in any of the properties currently receiving bottled water in the future (except possibly some of those locations that currently have a POET system).

Also, as discussed above, the data from PSWs at the properties currently proposed for discontinuation of PSW sampling (the current semi-annual locations) indicate no gasoline constituents are present above the MDE’s state action levels. Sampling will continue for the current monthly and quarterly sampling locations which would now be sampled quarterly and semi-annually, respectively. Should there be any indication of concern based on data from the extensive monitoring well network or from the current monthly or quarterly PSW locations, MDE can direct additional sampling as it deems necessary.

Based on the overall investigation and remediation, and supported by the PSW data included with this submission, ExxonMobil proposes to discontinue the provision of bottled water to those properties referenced herein and modify the PSW sampling schedule as described above. Should the MDE approve these proposals, ExxonMobil will a) provide written notification to those property owners listed on **Table 1** in advance of its discontinuing delivery of bottled water and b) advise those property owners of the applicable change to the PSW sampling frequency for their property.

ExxonMobil continues to work with the MDE to investigate and monitor any changes in the nature, extent and distribution of gasoline contamination in the area, including an evaluation of whether any individual wells may potentially be impacted by gasoline constituents above the MDE’s state action levels. If in the future, ExxonMobil or the MDE believes that a PSW will be impacted by gasoline constituents above the MDE’s state action levels, ExxonMobil will conduct, at the direction and with the approval of the MDE, one or more of the following: resume bottled water, install a POET system or increase sampling location(s) or frequency.






