#### 01. CALL TO ORDER

# **05. SECRETARY'S REPORT**

# A. Board Chair

1. Bill Shreve discussed working closely with Dinorah Dalmasy, the Manager of the Integrated Water Planning Program, Water and Science Administration at (MDE) Maryland Department of the Environment. Board Chair suggested putting a committee together to oversee vacancies and certification process in an effort to support the Water and Science Administrations' sustainability of the Chesapeake Bay initiative of future upgrades and performance measures for (67) major Wastewater Treatment plants; to include assisting with supply and demand of additional Certified Operators to meet proposed compliance goals for year 2025. Board Chair discussed follow-up of letter sent to Saeid Kasraei, Program Administrator and Lee Curry, Director (MDE) Water and Science Administration requesting that the Board be notified by December 31, 2019 of who will serve as Interim or Acting Board Secretary.

#### C. Report on Examination Results

Board Staff discussed the examination statistics for the month of December, 2019. There were 44 total exams taken in December, with an overall pass rate of 34.09%. Twelve operators sat for the paper water exams, scoring a pass rate of 33.33%; three operators sat for the online (AMP) water exam, scoring a pass rate of 33.33%; and six operators sat for the web-based water exams, scoring a pass rate of 50%. In December, thirteen operators sat for the paper wastewater and industrial wastewater exams, scoring a pass rate of 46.15%; three people sat for the online (AMP) wastewater and industrial wastewater exams, scoring a pass rate of 0%; and seven operators sat for the web-based wastewater and industrial wastewater exams, scoring a pass rate of 14.28%. A total of 908 exams have been taken calendar YTD.

2. Board Chair discussed future plans for partnership with community colleges to administer Certified Operator Exams. This plan would include a long term goal of moving toward all computer exams verses paper exams. Board suggest sending a correspondence to Karen Brandt of (MCET), Maryland Center for Environmental Training to assist with this initiative.

# A. Certified Operator Training and Renewal Process

- 1. Board discussed controversy regarding Utility generated Training Reports in response to the former Board Secretary's request that all Utility generated Training Reports must include signature of training Instructor, and or be accompanied by an official verification letter from utility. Board staff outlined the Operator Certification renewal process in accordance with Board of Waterworks and Waste System Operators Regulations 26.06.01.12 (Requirements for Renewal of All Certificates), and 26.06.01.13(Training). All Certified Operators applying for Certification renewal must submit copies of Board approved completion of training certificates taken within the renewal period of 3 years. Joseph Johnson presented a copy of (WSSC) Washington Suburban Sanitary Commissions Official letter for review.
- 2. Further clarification of Operators and Superintendents Training, Renewal and Reinstatement of Operator In Training Certification process in according with the Board of Waterworks and Waste Systems Operators Regulations 26.06.01.12 Section (B) Requirements for Renewal of All Certifications will be discussed next Board meeting to be held on February 20, 2020 at Anne Arundel County Water O & M, Millersville, MD 21108.
