SAMPLE SUMMARY CERTIFICATION

Lead in Drinking Water-Public and Nonpublic Schools

After the school has completed standard/routine sampling of all required outlets, the school must provide certification to the Maryland Department of the Environment (MDE) and the Maryland State Department of Education (MSDE) using this form.
